Remember to include all learning supports (the analysis worksheet) with your lesson plan. What is the purpose of the worksheet - how does it connect to the objective? Watch your timing (on the lesson plan you have the engage at 3-5 minutes). You spent much longer on the engage section (around 25 minutes). Good idea to tell students it was time to move on. I do - Read section 1 as a class - think of ways to engage the students in the reading. Instead of having students "guess" what they will be learning, tell them - "what will we be focusing on during this lesson?" Introduced terms by reading them to the students. We do-You do- Students worked on commercials about cities in the west. You did a nice job offering support to the students
